### ***BREEDING CONTRACT***

Prairie Hill Morgans and Susan Motter (stallion owner/leasee), hereinafter called Stallion Owner, hereby agree to breed:

Hereinafter called Mare Owner. The Mare Owner does hereby agree to have the said mare bred to: \_\_\_\_\_ under the following conditions:

1. The total breeding fee (including booking fee) shall be \$\_\_\_\_\_ and shall be paid by the Mare Owner to the Stallion Owner as follows:
  - a) \$200 paid as a booking fee upon execution of this contract. This fee is non-refundable for any reason & is deductible from the total breeding fee.
  - b) The balance of the breeding fee \$\_\_\_\_\_ shall be paid prior to departure of mare safely in foal that comes to Prairie Hill Farm for breeding OR for semen transport: 1/2 the balance of the breeding fee owed (after the booking has been paid) plus the first collection/shipping fee is due prior to the first shipment of semen being sent out. The remaining 1/2 of that balance due when mare has been ultrasounded 30 days in foal.

- c) The rates quoted above for the stallion, Baptiste Newman Bluet, apply to non-colorful Morgan mares only. The same breeding & shipping fees apply to all non Morgan mares.
2. Mare care shall be at the rate of \$\_\_\_\_\_/day for open mares & \$\_\_\_\_\_/day for mares with foals at side. All mare care shall be paid in full prior to departure of mare. Mare care rates are subject to change annually.
  3. The Stallion Owner shall have the right to obtain all farrier & veterinary services he deems necessary. All farrier & veterinary services are the financial obligation of the Mare Owner.
  4. Upon arrival of the mare, the Mare Owner shall provide the Stallion Owner the results of a current negative Coggins test, a health certificate from their veterinarian, a negative culture and a record of vaccinations.
  5. Stallion Owner shall exercise reasonable care for health & breeding of mare (and foal).
  6. The Stallion Owner shall not be responsible for injury, death, loss or damage to, or done by, said mare (and foal). Insurance for mare (and foal), if any, shall be the sole responsibility of the Mare Owner, the Mare Owner shall indemnify and hold the Stallion Owner harmless thereafter. The Mare Owner, however, shall not be responsible for damage to the stallion by the mare during breeding.
  7. The Stallion Owner guarantees to the Mare Owner a live foal. A live foal is one that is able to stand & nurse for 24 hours. In the event the foal dies before 24 hours, the Stallion Owner shall be notified, with a statement of details from a vet, within 10 days of the foal's death or the guarantee is null & void. The guarantee allows the Mare Owner to rebreed a substitution of mare is allowed with the approval of the Stallion Owner. Clauses 2 - 6 will still be applicable.
  8. The breeding season at Prairie Hill Morgans begins Feb. 15 and ends October 1st. Special arrangements must be made for breeding outside of those dates. Every effort will be made to breed the mare as necessary.
  9. In the event the stallion is unable to breed due to death, illness, injury, infertility, or other cause; the Mare Owner shall be allowed to breed to a substitute stallion at the Stallion Owner's discretion. Breeding fees will not be refunded for any circumstances. This contract is non-transferable without written consent of Mare Owner and Stallion Owner. 3 yr. limit on this contract.

The following clauses apply to semen transport:

1. A collection fee of \$\_\_\_\_\_ will be charged for same/day air shipments. A collection fee of \$\_\_\_\_\_ will be charged for Fed-Ex/personal delivery (or any

other type of shipment). This fee includes shipping costs. The first collection fee will be due prior to the first shipment. All charges shall be paid monthly and shall be paid in full prior to following shipments. Collection fees are subject to change annually.

2. The semen must be administered by a licensed veterinarian on the day of delivery and ONLY to the contracted mare or the above guarantees will not apply.
3. The container shall be returned within 5 days of receipt or a \$25/day penalty will apply until the container is returned. Containers may be returned via Fed-Ex or UPS to:
